3. DRAINAGE CALCULATIONS FOR STORMWATER DISCHARGE ONTO MAINE TURNPIKE AUTHORITY LAND, IF ANY
4. IF THE APPLICANT IS A CORPORATION, YOU MUST STATE THE CORPORATE ADDRESS AND STATE OF INCORPORATION.
5. NON-REFUNDABLE APPLICATION FEE OF \$250 MADE PAYABLE TO THE MAINE TURNPIKE AUTHORITY. (THIS APPLICATION FEE DOES NOT APPLY TO NON-PROFITS OR MUNICIPALITIES).

The applicant acknowledges and agrees that the Applicant shall be responsible for all costs incurred by the Maine Turnpike Authority acting in connection with the review, assessment, and negotiation of, and any necessary investigation into, any matters associated with this application for purchase of an interest in land owned by the Maine Turnpike Authority, including, but not limited to costs of reviewing any materials or documents submitted with the application; any field work done in connection therewith, and any engineering, survey, or legal fees associated therewith, whether or not the application is ever carried to a successful conclusion.

If, for any reason the Applicant fails to conclude or consummate necessary negotiations or actions, or fails to act within a reasonable period of time or withdraws, abandons, cancels or neglects the application, the Applicant shall pay, upon presentation of an invoice, the Maine Turnpike Authority, it's agents or assigns all actual costs incurred by the Maine Turnpike Authority up to that date and time.
