

- I. Contractors not currently prequalified by MaineDOT for Building projects can seek prequalification for this project prior to the award by submitting the prequalification application included in the contract front end

directly to the Authority at the above address. Contractors not currently prequalified by MaineDOT for Building Projects or Contractors not prequalified by the MTA for Building projects may not be awarded a contract for this project.

- J. A single addendum is planned for issuance on Friday, April 14, 2023. All questions need to be received by April 12, 2024 at noon.

- N. Proposals must be accompanied by an original bid bond, certified or cashier's check payable to the Maine Turnpike Authority in an amount not less than five (5%) percent of the Total Amount in the Proposal, but not less than \$500.00. The Bidder to whom a Contract is awarded will be required to furnish a Surety Corporation Bond, satisfactory to the Authority, on the standard Contract Bond form of the Authority, for a sum not less than the Total Amount of the Proposal.
- O. Proposals must be made upon the Proposal Forms furnished by the Authority separately with the Contract Documents and must be enclosed in the sealed special addressed envelope provided therefore bearing the name and address of the Bidder, the name of the Contract, and the date and time of Proposal opening on the outside.
- P. Contractor will be required to submit prior to and for inclusion with the contract documents, the following:
 - 1. Contract and insurance certificates
 - 2. Builders risk by owner
 - 3. Pay down schedule
 - 4. Schedule of values
 - 5. Anticipated Project Gantt schedule identifying project Critical Path Elements and including full project schedule timeline. This will be required to be submitted for each of the identified Owner-Contractor progress meeting.

- Q. Substantial Completion: Identified in the contract documents as September 03, 2024. Description provided in specifications as to what shall be completed.
- R. Final Completion: Identified in the contract documents as September 27, 2024 and shall result in full turnover of building and site to MTA.
- S. There is no current plan to deviate from the stated Substantial and Final Completion dates.
- T. Contractors may schedule site visits to review the existing conditions. Site visits shall be scheduled through Steve Tartre at 207-482-8144 or startre@maineturnpike.com.

II. **Questions** Discussed at the Pre-Bid Meeting:

A. Question: Can the project be turned over early?

Response: Yes, the project may be turned over early. It is intended that owner occupancy occur before winter, 2024.

B. Question: Will the contractor be afforded the option to Phase the project, versus continuous timeline until completion?

Response: It is the Authority's preference that the project be completed 240 days after commencement of the work. The Authority may entertain a phased project schedule if it determines that this approach will benefit the project.

This would require that the Contractor takes necessary precautions to protect any installed elements that would be subject to damage by the elements and/or frost during periods of shutdown. Any replacement of installed systems deemed necessary by the Authority or their representatives will be at the Contractors expense alone and at the discretion of the Authority.

C. Question: Are the LP tanks and underground piping by the contractor or owner furnished?

Response: The LP tanks and underground piping shall be furnished and installed by the contractor. The contractor shall notify MTA's fuel supplier (currently Dead River) a minimum of 10 days in advance of backfill for their inspection prior to filling the tank.

D. Question: What is the address for the project site?

Response: The project's address is One Chases Pond Road, York, Maine.

E. Question: Is design insurance required for the metal building design?

Response: Yes, as the construction documents require that all submitted materials be designed and sealed by a Maine Licensed Professional Engineer.

F. Question: Are there any contaminated soils?

Response: There are no known contaminated soils, however, a special provision will be added via the upcoming addendum in the event that contaminated soils are discovered during construction.

G. Questions: Are provisions required in the metal building design for solar panels?

Response: No, there are no such requirements.

H. Question: Are bidding contractors required to purchase plans.

Response: NO, but they are available for review and purchase. See Item K, Part 1 above.
