The following changes are made to the Specifications and Plans.

SPECIFICATIONS

- Special Provision Section 652 MAINTENANCE OF TRAFFIC (Specific Project Maintenance of Traffic Requirements), section Maine Turnpike under Route 111 Traffic Control Requirements is deleted and replaced with the following:

Maine Turnpike under Route 111 Traffic Control Requirements

Three lanes of traffic in each direction shall be maintained at all times on the Maine Turnpike under Route 111 except at times noted in Table A.

- Special Provision Section 652 MAINTENANCE OF TRAFFIC (Specific Project Maintenance of Traffic Requirements), section Maine Turnpike under Biddeford Interchange Bridge Traffic Control Requirements is deleted and replaced with the following:

Maine Turnpike under Biddeford Interchange Bridge Traffic Control Requirements

Three lanes of traffic in each direction shall be maintained at all times on the Maine Turnpike under the Biddeford Interchange Bridge except at times noted in Table A.

QUESTIONS

The following are questions submitted to the Maine Turnpike Authority in writing. Answers to the questions are noted. Bidders shall utilize this information in preparing their bid.

- Question 1:** On page SP-113 under “Maine Turnpike under Route 111 Traffic Control Requirements” and page SP-114 under "Maine Turnpike under Biddeford Interchange Bridge Traffic Control Requirements" it states that three lanes of traffic in each direction shall be maintained on the Maine Turnpike at all times. On plan sheet 47 of 48 it shows that the

clear protective coating and the parapet joint repair extends up, over and down the face of the parapet and would require access from below to complete. Will lane closures be allowed to complete this work?

Answer: Yes, lane closures will be permitted to complete the repair work on the fascia side of the parapets. Revisions to the Special Provisions and permitted lane closure windows are included in this addendum.
