The following changes are made to the Specifications.

SPECIFICATIONS

- Special Provision page SP-9: 105.242 Lead Paint In the fourth sentence of the first paragraph add "transportation" after "storage".
- Special Provision page SP-9: 105.242 Lead Paint In the first sentence beneath <u>Lead Paint Removal</u> add "transported" after "stored".
- Special Provision page SP-16: 506.01 Description Beneath the second paragraph under <u>Local Road Name Signs</u> add the following: "Sign brackets for road name plaques shall remain mounted to the bridge girders to permit the cleaning and painting of the brackets. The cost of cleaning and painting the sign brackets shall be incidental to related Contract Pay Items."
- Special Provision page SP-19: 506.035 Containment Plan Revise paragraph 4 to delete mention of "existing sign brackets" from the list of elements requiring protection.
- Special Provision page SP-21: 506.035 Containment Plan Add new section I to read "Where suspended platforms are located beneath bridge scuppers, all stormwater discharge from the scuppers must be managed to prevent erosion of earth slopes beneath the work area. The cost of stormwater management and erosion control shall be incidental to related Contract Pay Items."
- Special Provision page SP-29: 506.11 Waste Management In the first sentence add "transport" after "store".

QUESTIONS

The following are questions asked following the pre-bid conference held on September 9, 2025. Answers to the questions are noted. Bidders shall utilize this information in preparing their bid.

Question 1: Can bridge to grade containment system with cables and stage scaffolding be utilized in lieu of rapid deployment trucks for each lane closure?
 Answer: No. All work above pavement must be conducted from a rapid deployment unit. Bridge to grade containment systems are not permitted.
